After School Program Offerings

Tutoring Classes Before & After School

Kindergarten- Phonemic Awareness, Phonics, Alphabetic Principle, Oral language skills, Math Concepts

First Grade-Phonemic Awareness, Phonics, Alphabetic Principle, Vocabulary, Oral language skills, Math Concepts

Enrichment Activities

Example Sessions (Sessions vary by site)

Chorus/Glee Club – Many of our students love to sing. There are options for those students to learn songs and perform at school functions.

Character Building – Character building session for all students using related activities and games, including letters to servicemen, notes for nursing home patients

Board Games – Board and card game session for all students, with instruction in playing a large variety of games, guiding the children in problem solving skills, competition, working cooperatively as well as the importance of winning and losing graciously.

Building with Brick Labs– As the name implies, the students work in groups to build structures using the interlocking pieces. This skill falls right in line with S.T.E.M. learning for our students.

Physical Education Games/Skills/Fun – Physical activity session designed to have fun, gain motor skills, build stamina and learn how to play recreational games for fitness.

Computer Lab – Students enjoy sessions in the computer lab, working on skills using technology.

Arts & Crafts – Arts and crafts session for all students, using various mediums, also relating to holidays as well as cultural themes.

Parent/Student Handbook

Enrollment

Parents or guardians of students at each site may apply for the 21st CCLC Before & After School Program by completing and signing an application, then returning that document to school. Those students ‘at risk’ academically, will be offered the program first. All other students will then be offered program. Classes will be filled on a ‘**first come, first serve**’ basis. Student applications received after class sessions have begun will be placed on a waiting list if space is not available in the current sessions.

Parent/Guardian Responsibilities

There is no cost for student participation in the 21st CCLC Before & After School Program. **Due to the COVID-19 Pandemic, visitors to the program will be limited, following the guidelines set forth by Hardin County Schools, in order to keep our students and staff safe. This includes parents entering the buildings as well. Parents checking out students early will need to stop in the office. Parents picking up students at end of day need to stay in their cars. We would ask your cooperation at this time.**

Dismissal time for the 21st CCLC Before & After School Program **begins at (5:15 p.m.)**. Parents may sign their child up for dismissal at an earlier time, with strict adherence to the schedule unless the school is notified as to a need for change prior to the date of said change. Students **must be picked up by 5:25pm**. Failure to pick up students by 5:25pm will result in a “**Strike**”. A three (3) strike policy will be in place, with students being removed from the program after receiving 3 strikes. Students may reapply the next school year to the program if dropped from the program. Students may receive a strike for late pick up (after 5:25) as well as unacceptable behavior. Parents are asked to cooperate with staff in stressing the importance of good behavior patterns for all children. It is imperative that parents work with the Program Coordinator to correct any behavior that is interfering with the child’s success in the program. This helps to keep the program fun as well as instructionally sound.

Parents who demonstrate abusive language and/or inappropriate scenes or disturbances to children, staff, or other adults during the program hours will be asked to withdraw their children from the program. Harassment or bullying will not be tolerated.

Discipline Policy:

All rules of the Hardin County behavior and discipline policy apply during the 21st CCLC Before & After School Program.

Children enrolled in the program are expected to exhibit behavior which does not disrupt or interfere with the school climate or the learning process and social interaction of other children. The program staff will enforce school rules throughout the program hours. Parents will be notified in writing when a major discipline problem occurs. A “**Three (3) Strike and You are Out**” policy will be followed. When a student receives a strike, parents or guardians will be notified. If a student receives strike #3, they will be removed from the program for the remainder of the school year. Students may reapply to the program the following year.

An exception to the above is when a major incident (deemed by the Program Coordinator) occurs. This will result in immediate suspension. The Zero Tolerance Policy for the school district applies for the program.

Rules of Conduct for Students:

The following behaviors are considered inappropriate and unacceptable in the program. These behaviors may result in immediate suspension:

- Possession of weapons, contraband, and other dangerous objects (Zero Tolerance Policy Applies)
- Fighting, wrestling, spitting (with or on peers or staff)
- Destruction of center/school property
- Destruction of personal property of another person
- Vulgar Language, Cursing
- Improper display of private body parts
- Disrespectful behavior to other children or staff
- Climbing on desks, tables, cabinets, etc.
- Playing in the bathrooms (crawling under stalls, climbing on sinks, splashing water, turning on/off lights etc.)
- Throwing balls, or other outside equipment while inside the building
- Stealing
- Physical attacks on staff or other students (Zero Tolerance Policy Applies)
- Tackle football
- Improper use of program and school equipment
- Throwing objects (rocks, sticks, desks, tables, etc.)
- Leaving group without permission (i.e. running away, hiding, etc.)
- Behavior deemed inappropriate and unacceptable by the Program Coordinator or Program Supervisor.
